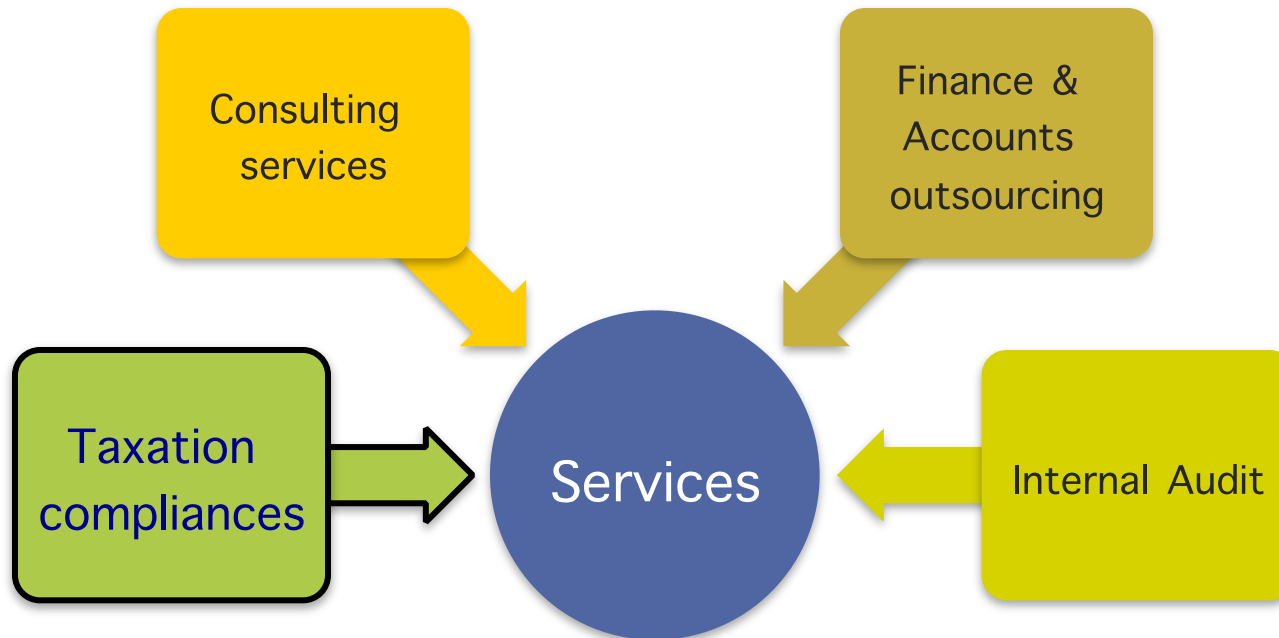

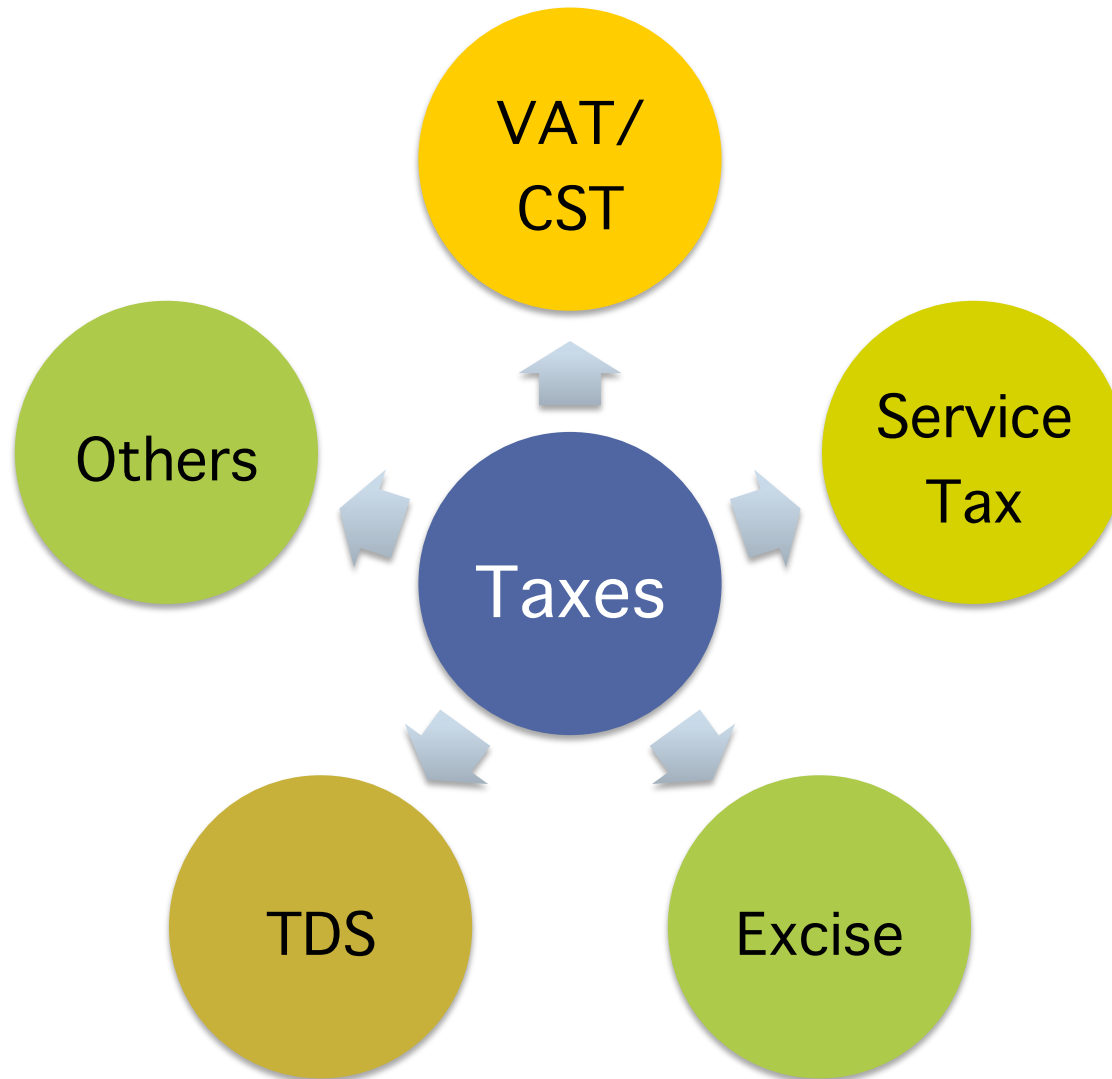

Note:

The scope of work for tax compliances in the next few slides is general in nature which may expand/reduce as per the actual requirement of the client.



- Checking of invoices for charging of VAT as per the applicable provisions of VAT law of the respective State.
- Calculation of monthly VAT/CST liability to be deposited.
- Checking of input VAT to ensure that correct input credit has been claimed and utilized.
- Preparation of challan for payment of taxes.
- Preparation and filing of tax return as per the frequency based on the VAT provisions of turnover and respective State's VAT law.
- Management of Forms i.e. C Form, F form etc.



- Co-ordination with tax consultants at pan India level for any query from the department in a respective State.
- Preparation of any information/detail required at the time of assessment.
- Preparing and submitting monthly tax compliance report and sharing a real time dash board of the compliance status.



- Checking of invoices for charging of service tax as per the applicable provisions of service tax law
- Checking of input service tax to ensure that correct input credit has been claimed and utilized.
- Preparation of monthly service tax liability being deposited.
- Preparation and filing of service tax return.
- Represent company during the service tax audit initiated by the department.
- Ensuring compliance with various provisions of service tax law i.e. Point of taxation rules, Abatements, Reverse charge mechanism, input credit distribution etc.



- Verification of correct deduction of withholding tax as per the latest applicable provisions of the Income Tax Act, 1961.
- Calculation of tax liability for the month under different provisions related to TDS.
- Preparation and submission of TDS return as per the specified frequency.
- Issuance of Form 16A within the specified time period.
- Reply to department's query/notice related to TDS return submitted.
